IMPORTANT NOTICE UPDATE

Paramedic protocol exams, both written and practical will only be conducted on Wednesday afternoons by appointment. Please try to schedule at least 2 weeks in advance.

An email address and phone number of the candidate will be needed at the time the appointment is made. A meeting notice will be sent to the candidate and Wendy Moudy, Training Coordinator.

A separate email will be sent to the supervisor notifying them of the date and time of the protocol exam.

Below is the information that will be provided to the candidates when the meeting notification is sent.

Expect the protocol test to last between 3 to 4 hours. You should arrive well-rested and ready for both a written, and hands on practical assessment to demonstrate proficiency in using current ACLS in conjunction with Yakima County protocols.

Clothing attire: Dress in comfortable **non-agency identifying** clothing that you are able to perform routine medical or trauma assessment skills in. Bring a watch, at minimum. We will provide you with additional medical assessment tools such as a stethoscope, blood pressure cuff, and cardiac monitor. It is the paramedic's responsibility to operate the training monitor provided by our office. There will be no accommodations or training provided on the day of the test. Paramedics are welcome and encouraged to bring their own equipment if and when available, including their agency specific monitor.
